The District of Columbia Immunization Law requires that all students under the age of 26 provide proof of certain immunizations prior to registration for classes. Certification of the following immunizations or evidence of positive immunity is required: Tetanus/Diphtheria (Td) or Tetanus/Diphtheria/Acellular Pertussis (Tdap), Measles/Mumps/Rubella (MMR), Hepatitis B (HepB), Varicella (Chicken Pox).

Unless you meet one of the exemption categories listed at the bottom of the form, please have your health care provider fill in the dates when you received your immunizations, sign and return this form to IWP at the address listed above. Keep a copy of this for your records.

I understand that if I have not received immunizations due to medical or religious grounds, I may be temporarily excluded from my classes and from participating in IWP-sponsored activities during a vaccine-preventable disease outbreak or threatened outbreak.
